Policy for Chemical Defense Equipment Used as Training Assets

- Due to the continued costs of marking, accounting and distributing training assets, as well as austere funding concerns within the Defense Accountability, Reutilization and Disposal (DARD) Project, the following changes to the subject policy letter are provided.
- 2. Change Paragraph 1 on the original policy letter to read:
 - "This policy letter applies to Clothing and Textile (IPE) Individual Protective Equipment (i.e., suits, gloves and boots), used for training."
- 3. Change Paragraph 3 on the original policy letter to read:
 - "Available Chemical, Biological, Radiological and Nuclear Defense IPE assets for training purposes may be requisitioned from the Joint Equipment Assessment Program, Defense Accountability, Reutilization and Disposal Program (DARD). There will be a minimal handling charge assessed on each NSN requested, as well as a shipping charge. Both are the responsibility of the requesting unit/Command.
- 4. This policy change is effective immediately and supercedes any previous guidance.

Policy for Chemical Defense Equipment Used as Training Assets

- 1 This policy applies to all Individual Protective Equipment (IPE) used for training
- Services may acquire IPE training assets from their own resources or request training assets via the DOD Shelf Life Management System website: http://shelflife.pmnbc.com. This website is managed by the Joint Equipment Assessment Program.
- Training assets may be requisitioned at no cost; however, the requesting unit will be responsible for all shipping costs.
- 4. All assets designated for training will be marked "TRNG ONLY." Markings will be silk screened or marked utilizing appropriate ink durable enough to withstand continuous use. In the case of garments, the markings must withstand a minimum of five washings performed in accordance with procedures for laundering JSLIST garments.
- Marking items designated for training, will be performed by the using unit in accordance with the following guidelines:
- Training Suits. Coats and trousers will be silk-screened "TRNG ONLY" in 2 ½ inch
 white letters using plastic based resin ink, as shown in Enclosure (1). The coat will
 be marked on the back, 5 inches below the collar and centered between the
 shoulders, as shown in Enclosure (2). The trousers will be marked on the right leg,
 centered 1 inch below the pocket along the vertical axis, as illustrated in Enclosure
 (2).
- Training Boots. Boots will be marked "TRNG ONLY" in ½ inch to ¾ inch white letters using an opaque white ink as shown in Enclosure (1). Each boot will be marked on the outside, 2 inches from the top of the boot, as illustrated in Enclosure (2).
- Training Gloves. Gloves will be marked "TRNG ONLY" in ½ inch to ¾ inch white letters using an opaque white ink, as shown in Enclosure (1). Each glove will be marked on the palm side of the glove, 1 inch from the glove opening, as illustrated in Enclosure (2).
- Items presently marked as training assets are not required to be remarked
- Training assets no longer suitable for use will be turned in to the Defense Reutilization and Marketing Service (DRMS) for disposition under current directives.

Policy for Chemical Defense Equipment Used as Training Assets

IPE garments removed from their sealed bag, not used for training and not required for unit operations, will be positively controlled by the unit and will be turned in to DRMS for disposition.
