SUPPLEMENTATION. Supplementation of this regulation and issuance of command and local forms are prohibited without prior approval of HQ Eighth U.S. Army (EAGA-PP), Unit #15236, APO AP 96205-0009.

INTERNAL CONTROL PROVISIONS. This regulation does not contain management control procedures.

- **1. PURPOSE**. This regulation provides information and administrative instructions for the Sergeant Audie Murphy Club (SAMC) within Eighth United States (U.S.) Army.
- **2. APPLICABILITY.** This regulation applies to all Eighth U.S. Army subordinate commands, assigned or attached units, and tenant units.

3. REFERENCES.

4. EXPLANATION OF ABBREVIATIONS AND TERMS.

b. Terms.

- (1) Sergeant Audie Murphy. The name of a Noncommissioned Officer (NCO) who, as a squad leader, consistently demonstrated the highest qualities of leadership, professionalism and regard for the welfare of his soldiers. A brief biography of Audie Murphy is at appendix A.
- (2) Sergeant Audie Murphy Club. An elite organization of NCOs whose demonstrated performance and inherent leadership qualities and abilities are characterized by those of Sergeant Audie Murphy. The SAMC emblem is represented at appendix B along with an explanation of the lineage.

5. RESPONSIBILITIES.

- a. Commanders of Eighth U.S. Army major subordinate commands (MSCs), assigned or attached units, and tenant units will--
- (1) Establish criteria, policies, and procedures to govern nomination of candidates for induction into the Eighth U.S. Army SAMC from within their MSC.

- (2) Nominate candidates for induction into the Eighth U.S. Army SAMC to their respective brigade-level Initial Selection Board.
 - b. The Command Sergeants Major (CSMs) 2ID, 19th TSC, and 1st Sig Bde will--
- (1) Convene quarterly Eighth U.S. Army final selection boards to consider nominees for induction into the Eighth U.S. Army SAMC. Appendix C depicts how units are aligned.
 - (2) Serve as presidents of the Eighth U.S. Army Final Selection Boards.
 - (3) Provide a recorder without vote for quarterly Eighth Army final selection boards.
- (4) Publish Memorandum of Instruction for SAMC board and induction ceremony when required.
- (5) Within 3 working days of the board, provide ACofS, G1 (EAGA-PP) the SAMC Induction Worksheet (Appendix D) for soldiers selected for induction into the Eighth U.S. Army SAMC.
- (6) Counsel candidates not selected for induction who appear before the Eighth U.S. Army Final Selection Board.
- (7) Exercise final authority for approval of any policy or procedural exceptions, to include SAMC member removal actions.
- (8) Inform the Eighth U.S. Army ACofS, G1 of gaining units of assignment of departing SAMC members within their MSCs no later than 30 days prior to the member's scheduled departure date.
 - c. The Eighth U.S. Army Assistant Chief of Staff (ACofS), G1 will--
- (1) Prepare EA Form 527 (Eighth U.S. Army Sergeant Audie Murphy Award) signed by the Eighth U.S. Army Commanding General and CSM.
- (2) Provide a membership medallion, approved for wear with the class A uniform during SAMC official functions only (in accordance with AR 670-1, paragraph 28-13d).
 - (3) Prepare EA Form 525 (Sergeant Audie Murphy Membership Card).
- (4) Prepare introductory memorandums for departing SAMC members for signature by the Eighth U.S. Army Command Group.
 - (5) Maintain Eighth U.S. Army SAMC Database of inductees.
- d. The Eighth U.S. Army Public Affairs Officer will provide media coverage and photography support of awards presentation ceremonies, as required.

- e. The Brigade CSMs will--
- (1) Convene SAMC Initial Selection Boards to coincide with outstanding noncommissioned officer, soldier and Korean Augmentation to United States Army (KATUSA) boards to consider recommending candidates for induction into the Eighth U.S. Army SAMC.
 - (2) Serve as members of Eighth U.S. Army Final Selection Boards.
- (3) Forward nomination packets for candidates recommended for induction into their Eighth U.S. Army Level Final Selection Board President. The documents required for the nomination packet are listed at Appendix E.
 - (4) Counsel those candidates who are not recommended to the Final Selection Board.
- (5) May publish a memorandum of introduction signed by the MSC commander for gaining commanders of SAMC members departing their command; in lieu of, requesting an introduction letter from the Eighth U.S. Army Command Group. A sample letter is at appendix F.

6. POLICY.

- a. Induction and membership in the SAMC is a reward for NCOs whose leadership achievements and performance merit special recognition. The SAMC is a means of recognizing those NCOs who have contributed significantly to the development of a professional NCO Corps and a combat-ready Army. Members exemplify leadership characterized by personal concern for the needs, training, development and welfare of soldiers and concern for families of soldiers.
 - b. Eligibility. All NCOs in the ranks of Corporal through Sergeant First Class.
 - c. Quotas for SAMC inductees will not be established.
 - d. Honorary membership.
- (1) Selected personnel who fit the image of a SAMC member but would not normally be allowed to compete may be awarded honorary membership.
- (2) Sergeant Morales members in good standing will be extended honorary membership. They will receive a membership card and the opportunity to participate in all SAMC activities. However, they will not receive an award certificate or medallion.
- (3) All recommendations for honorary members will be forwarded through the ACofS, G1 SGM to the Eighth U.S. Army CSM for approval.
- e. Unit files and military personnel records will be reviewed to verify the existence or absence of disciplinary action. A ration control and Provost Marshal Office check must be conducted and any derogatory information addressed. Commanders may provide a statement instead of hard-copy records. Minor violations should not automatically disqualify soldiers from being nominated.

- 7. **PROCEDURES.** The SAMC selection process will be in four phases.
- a. Phase 1 Commander's evaluation/nomination. Commanders who recommend NCOs for membership in the SAMC will screen and evaluate candidates prior to appearance before an initial selection board.
 - (1) A sample format for the commander's evaluation/nomination is at appendix G.
- (2) A DD Form 2266 (Hometown News Release Information), a performance test of the recommended individual, and an enlisted records brief (ERB) will be attached to the commander's evaluation/nomination.
- b. Phase 2 Performance test. The SAMC performance test is based on recorded accomplishments of the candidate and his/her subordinates (when applicable) and must be attached as an enclosure to the commander's evaluation/nomination. A sample format of the performance test is at appendix H.
 - c. Phase 3 Initial Selection Board. A brigade-level Initial Selection Board will be conducted.
- (1) Initial selection boards will be held in conjunction with quarterly outstanding NCO, soldier and KATUSA boards.
- (2) CSMs will appoint board members, ensuring that the board is composed of members senior to the candidate. Additionally, the board will include at least one voting member of the same sex as the candidate being considered.
- (3) Numerical scoring on subject matter contained on the score sheet at appendix I will determine if a candidate should continue in the selection process.
- (4) Candidates selected to continue will be scheduled to appear before the Eighth U.S. Army Final Selection Board. Requests to appear before the Eighth U.S. Army Final Selection Board will be by memorandum to the Eighth U.S. Army Final Selection Board president, signed by the appropriate commander. Nomination packets described in appendix E will be attached as enclosures to all appearance request memorandums.
- d. Phase 4 Final Selection Board. The Eighth U.S. Army Final Selection Boards will convene quarterly (in the months of September, December, March, and June). Requests for appearance and nomination packets will be submitted no later than the 5th workday of the months indicated.
- (1) The Eighth Army Final Selection Boards will be composed of the President of the boards, (2ID CSM, 19th TSC CSM, and 1st Sig Bde CSM) and the CSM or Sergeants Major appointed by them, and a recorder without vote. At least one board member must be of the same sex as the candidate being considered.
- (2) Candidates will appear before the final selection board in the class A uniform. Uniform for board members is at the discretion of the SAMC final selection board presidents.

- (3) The final selection boards will determine through a question and answer system if the candidate has sufficiently reached a level of knowledge in a wide range of areas to warrant induction into the SAMC.
- (4) Candidates successfully meeting the standards of the Eighth U.S. Army Final Selection Boards will be selected for induction into the SAMC. The inductee will be introduced to the local SAMC chapter and presented with appropriate awards.
- (5) The Eighth U.S. Army Final Selection Boards need not select candidates if they do not meet required standards.
- e. Requests for removal of SAMC members will be submitted to the Eighth U.S. Army CSM for evaluation and final determination.

APPENDIX A

THE BIOGRAPHY OF AUDIE MURPHY

Audie Leon Murphy was a legend in his own time. A war hero, movie actor, writer of country and western songs, and poet, his biography reads more like fiction than fact. He lived only 46 years, but he made a lasting imprint on American history. Audie was born on a sharecropper's farm in North Texas on June 20, 1924. As a boy, he chopped cotton for one dollar a day and was noted for his feats of daring-do and his accuracy with a gun. He had only 5 years of schooling and was orphaned at age 16. After being refused enlistment during World War II in both the Marines and Paratroopers for being too small (5' 5") and underweight (110 pounds), he enlisted in the United States Army a few days after his 18th birthday. After basic training at Camp Wolters, Texas, and advanced training at Fort George G. Meade, Maryland, Audie was sent overseas. He was assigned to the famous 15th Infantry Regiment of the 3rd Infantry Division where he fought in North Africa, Sicily, Italy, France, and Germany. He earned a battlefield commission for his courage and leadership ability as well as citations and decorations including every medal for valor that America gives. He was also awarded three French and one Belgian medal. Lieutenant Audie Murphy was the highest decorated soldier in American history. Discharged from the Army on September 21, 1945, Audie went to Hollywood at the invitation of movie star James Cagney. He remained in California for the rest of his life and was closely associated with the movie industry, both as an actor and a producer. He acted in 44 films, starring in 39 of them. His best known film was "To Hell and Back," adopted from the best selling book of his war experiences by the same name. Most of his movies were westerns. In 1955, Audie Murphy was voted the Most Popular Western Actor in America by the Motion Picture Exhibitors. Audie wrote the lyrics to 16 country and western songs, the most popular of which was "Shutters and Boards," written with Scott Turner in 1962. The song was recorded by over 30 pop singers, including Jerry Wallace, Dean Martin, and Porter Waggoner. He was an accomplished poet; unfortunately, only a few of his poems have survived. In 1950 Audie joined the 36th Infantry Division ("T-Patchers") of the Texas National Guard and served with it until 1966. He was a Mason and a Shriner and belonged to several veterans' organizations. Audie Murphy was killed in a plane crash on a mountaintop near Roanoke, Virginia on May 28, 1971. Fittingly, his body was recovered 2 days later on Memorial Day. Audie could very well be the last American war hero. He was the greatest combat soldier in the 200-year plus history of the United States.

SSG Rank Insignia: Reflects Audie Murphy's highest enlisted rank.

The Laurel: Represents the individual achievement of the NCOs in the club.

The Lightning Bolt: Represents swift and decisive action taken by the NCO.

The Sword: A historical reference, a tool for the NCO to cut to the heart of the matter, to lead the charge.

The Streamers: Indicate upon which we base our philosophy.

- D. Updated copy of Enlisted Records Brief (ERB)
- E. Copy of current Weapons Qualification Scorecard
- F. Copy of current DA Form 705 (APFT Scorecard)
- G. Verified Height and Weight Data, current within 3 days
- H. SAMC Performance Test Results
- I. One-page essay, written by candidate on an Army Values
- J. DD Form 2266 (Hometown News Release Information) with original signatures

(Nomination packets, the original plus six complete copies, must be turned into the selection authority by the suspense date established in the board Memorandum of Instruction.)
